Pursuant to Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the General Circulars No. 14/2020 dated 8th April 2020, No. 17/2020 dated 13th April 2020 read with other relevant circulars, including General Circular No. 9/2024 dated 19th September 2024 issued by the Ministry of Corporate Affairs, Government of India ("MCA Circulars"), the consent of the Members of the Company was sought, for passing the resolution set out in the Postal Ballot Notice dated 28th October 2024 by means of voting through electronic means (remote e-voting) only.

The last date for receipt of voting through electronic means was Thursday, 12th December 2024, 5:00 PM.



The Board of Directors at their meeting held on 28th October 2024, had appointed Mr. M D Selvaraj, FCS, Managing Partner of M/s. MDS & Associates LLP, Company Secretaries, Coimbatore, as Scrutinizer to conduct the Postal Ballot voting through remote electronic voting means in a fair and transparent manner and for the purpose of ascertaining the requisite majority.

Accordingly, the Scrutinizer has submitted his report on postal ballot (remote e-voting) and based on his report, it is hereby declared that the resolution set out in the Postal Ballot Notice dated 28th October 2024, has been duly passed by the members of the Company with requisite majority. Responsibility of the Management

Responsibility as a Scrutinizer

My responsibility, as a Scrutinizer for the Postal Ballot through Remote E-voting process is restricted to the preparation of a Scrutinizer's Report on the votes cast "in favour" or "against" the resolution, as set out in Item No. 1 of the Postal Ballot Notice dated 28th October 2024, based on the reports generated from the e-voting system provided by M/s. National Securities Depository Limited ("NSDL"), the Authorized Agency, engaged by the Company for providing remote e-voting facilities.

- a. The Postal Ballot Notice dated 28th October 2024 along with necessary statement setting out the material facts under Section 102 of the Companies Act, 2013 were sent on Tuesday, 12th November 2024 through electronic mail to those members whose names appeared in the Register of Members / List of Beneficiaries as on Friday, 8th November 2024 ("cut-off date") and who had registered their email address with the Company/ RTA/ Depositories in compliance with the MCA Circulars. The Company has also placed the notice of the Postal Ballot on the website of the Company.
- b. The shareholders of the Company holding shares as on the "cut-off" date on Friday, 8th November 2024 were entitled to vote on the proposed resolution as set out in Item No. 1 of the said Postal Ballot Notice.
- c. The remote e-voting period remained open from Wednesday, 13th November 2024 at 9:00 AM (IST) till Thursday, 12th December 2024 at 5:00 PM (IST). During the said period, the members of the Company, holding shares in physical and / or in dematerialized form, as on the cut-off date i.e., 8th November 2024 were entitled to vote on the resolution set out in the Notice of postal ballot through remote e-voting.
